

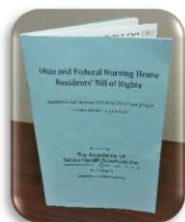

## Ohio News

### 1. ODM to change vendor payment schedule

The Ohio Department of Medicaid notified the SNF provider associations this week that they will be changing their vendor payment schedule for managed care and SNF fee-for-service. According to ODM, the goal is two-fold: spread payments equally across the month while drawing down federal dollars earlier in the month. To do this, ODM will pay those with the highest federal match - CHIP and Group VIII - first. The result is that SNFs will no longer get paid in week two of the cycle and will be paid in week four instead. ***This November, SNF vendor payments will be later in the month and will remain during the third full week of the month going forward.*** From ODM: Ohio Medicaid is implementing some MITS payment schedule changes beginning in November of 2017 in an effort to even out payments through the month. Details listed below:

What's changing? The schedule of MITS payments for Managed Care CAP Payments & Nursing Facilities in (FFS)

- Managed Care Payments will be made over 4 weeks instead of 3
- Payments to Nursing Facilities in FFS will move from the first week to the third week of the month

- Actual Payment shift begins during the month of November, 2017
- Additional payment schedule changes may be implemented in the future (for other groups)

For Planning Purposes:

- Week 1 is the first week of the month where Monday and Thursday are in the same month
- Week 1 is the week after the first Friday of the Month
- Week 4 will pay in Week 3 - in months with three cycles

## 2. Memory care unit advisory committee holds first meeting

House Bill 470 directed the Ohio Department of Aging and Ohio Department of Health to submit recommendations for standards and procedures for the operation of memory care units in Ohio and quality of care metrics for measuring memory care unit performance. ODA convened a group of stakeholders this week to begin developing those recommendations. It was noted that the group does not have to have consensus on the recommendations although that is the goal. The group considered how to define a memory care unit. There was some agreement that the definition should apply to both RCFs and NFs and include a cognitive impairment requirement, although not a medical diagnosis. There was some dissension regarding how to enforce any standards developed by the group. The Academy expressed concern over increased government regulations without considering the fiscal impact. The Academy also noted how the market should be allowed to drive consumer choice, not the government. The group will reconvene next week to discuss pre-admission forms, person centered care and the physical environment. [\(back to top\)](#)

## 4. ODM looking to move forward with MLTSS study committee

The Ohio Department of Medicaid will continue with process of preparing the next administration for managed long-term services and supports by working with the committee created in H.B. 49. ODM has said they hope to convene the committee this fall. The department would not elaborate on how "prepared" they will be to implement MLTSS for the next administration. They did express a desire to continue to work on improvements both in the context of managed care and for the entire LTC Medicaid delivery system. [\(Back to top\)](#)

## 5. Elder abuse, voyeurism, palliative care bills progress

The Senate Judiciary continued to hold hearings on S.B. 158 this week. The bill would increase public awareness of elder fraud, divert some fines to adult protective services and increase education requirements, among other changes. It has generated broad support with the only concern raised about the fines being diverted from local governments to adult protective services. The bill is on the docket for another hearing next week. H.B. 68, which cleared the House in June, has been assigned to the Senate Judiciary committee and is up for its first hearing. The bill would treat sexually orientated material of a cognitively impaired elderly person the same as for minors. It would also prohibit a health care facility and their staff to create or use any image of

the resident without a proper purpose and prior consent. Finally, a palliative care bill (H.B. 286) is ready to move forward after a provision that would have fined a health care facility for not identifying residents that could benefit from palliative care. The requirement remains in the bill without the penalty. The bill also creates a council for palliative care council and education program. [\(Back to top\)](#)

## 6. Hospitals fight proposed cuts, say not necessary

The Ohio Department of Medicaid still plans on cutting hospital rates by 5% in order to fill what they believe is a shortfall in the state budget. In testimony before the legislative Joint Medicaid Oversight Committee, ODM director Barbara Sears noted the cuts were necessary because not all of the policies proposed in the administration's budget made it through the process and the changes made created a shortfall. Hospital representatives are calling the cuts premature and noted that the current freeze on rates should contain costs enough for the current Medicaid appropriation level. At the very least, they contend, wait until the budget is in the red before making cuts. Dir. Sears believes the department needs to make the cuts now to balance Medicaid expenditures over the fiscal year and avoid making deeper cuts in the future. She also said the cuts would be removed if expenditures would align with appropriations without them. [\(Back to top\)](#)

As part of its early stakeholder outreach, BELTSS is notifying the public that it intends to modify 4751-1-02 (Definitions), 4751-1-04 (Board Meetings), 4751-1-05 (Pre-examination requirements), 4751-1-08 (Registration of institutions), 4751-1-081 (Training agency approval), 4751-1-09 (AIT Program), 4751-1-13 (Continuing Education), 4751-1-10.1 (Timely Renewal), and 4751-1-16 (Fees). ### 8. GOP looks to pass ACA repeal replace; block grant Medicaid, cut FPF max

The GOP is not ready to give-up on a repeal and replacement of the ACA. Senate leaders have been working hard this week to garner the necessary 50 votes to pass legislation that would remove many of the ACA provisions. The Senate has a session scheduled for September 30, the deadline for passing the legislation. The bill would block-grant Medicaid using a per-capita method and tie the amount to a consumer price inflation index, limiting its growth below the health-care inflation index. More concerning to SNF providers in Ohio, it would lower the maximum franchise permit fee amount to 4% of revenues. This would reduce the amount of fees the state could use to drawdown federal matching funds. The state would have to find funding for the resulting shortfall in federal funds. As of now, there is too much uncertainty on how Senators will vote to determine if the bill will pass. [\(Back to top\)](#)

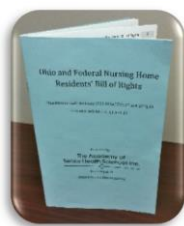
